## ALPINE MOUNTAIN RANCH METROPOLITAN DISTRICT RESOLUTION TO AMEND 2018 BUDGET

WHEREAS, the Board of Directors of Alpine Mountain Ranch Metropolitan District adopted the budget and appropriated funds for the 2018 fiscal year as follows:

General Fund:	\$ 26,669
Water Enterprise Fund:	\$ 55,200
Debt Service Fund:	<u>\$753,867</u>

Total \$835,736

WHEREAS, additional expenditures in the General Fund and Water Enterprise Fund are necessary resulting in expenditures in excess of appropriations for the 2018 fiscal year; and

WHEREAS, such additional expenditures are contingencies which could not have been reasonably foreseen at the time of adoption of the budget; and

**WHEREAS**, funds are available for such expenditures from unanticipated revenue (other than property taxes) or other surplus funds in the General Fund and Water Enterprise Fund.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Directors of Alpine Mountain Ranch Metropolitan District hereby adopts a supplemental budget and appropriation for the 2018 fiscal year as follows:

General Fund:		\$ 75,811
Water Enterprise	e Fund:	\$ 114,183
Debt Service Fu	nd:	\$1,470,333
	Total	\$1,660,327

**BE IT FURTHER RESOLVED,** that such sums are hereby appropriated for expenditure from any available funds in the General Fund and Water Enterprise Fund in accordance with the provisions of §29-1-109, C.R.S.
